SUBJECT: 2024 - 2025 NATIONAL YOUTH PROGRAM

We have always believed that the National Youth Program administered by the Veterans 3rd Vice Commander and Auxiliary 3rd Vice President is one of the most important programs for our organization. - **Late entries will not be judged.**

- The Thomas J. Cuite & Immaculate Conception Burse (ICB) Scholarship foundation awards a maximum of five (5) \$1,000 scholarship grants in the applicant's name paid directly to the applicant's accredited college or university upon receipt of proof of acceptance from the school. Begin the application process early to avoid missing the June 1st deadline! Youth Activity Contest Winners

- Each Post and Auxiliary Unit should determine their winners (1st, 2nd and 3rd place). These winners are then forwarded to their Department echelon for judging. Posts and Auxiliary units not under a Department should pick one (1) winner and forward it directly to National Headquarters via email.
- The Department echelon will judge contest winners (1st, 2nd and 3rd place).
- The Department will then forward three (3) winners to National Headquarters for judging. When a state has a Department echelon for both the Veterans and the Auxiliary, National HQ will only accept three (3) entries regardless of whether the entry was sponsored a by a Post or an Auxiliary Unit.
- All entries to the National echelon should be scanned digitally into a PDF or JPEG file and sent as an attachment in the email. Please do not embed digital images into the text of the email.
